Applications in the prescribed form are invited for admission to a competitive examination for recruitment to 74(seventy-four) posts of the Odisha Education Service-II (School Branch), Group-B under Department of School & Mass Education in the States pay scale of ₹9,300-34,800/- carrying the Grade Pay of ₹4600/- with usual allowances sanctioned by Government of Odisha from time to time. The posts are temporary but likely to be made permanent.

## **2. VACANCY POSITION :**

(a) Out of 74 vacancies, the following 5 posts are reserved for Ex-Serviceman, Physically Handicapped & Sports Persons.

- (i) 1(One) - Ex-Serviceman;
- (ii) 3(three) - Physically Handicapped persons –
  - (I) 1(One) - PWD (Blind) having low vision/partially blind,
  - (II) 1(One) - PWD (Deaf) Partially Deaf &
  - (III) 1(One) - PWD (OH)-
    - (a) Both legs affected but not arms,
    - (b) Both arms affected (i) Impaired; (ii) Weakness of grip.
    - (c) One leg affected, one arm affected (i) Impaired reach (ii) Weakness of grip.
- (iii) 1(One) - Sports Persons.

The candidates belonging to P.H/Ex-Servicemen./Sports person shall be adjusted against the categories to which they belong.

(b) In case of non-availability of eligible/suitable women candidates belonging to the respective category, the unfilled vacancies shall be filled up by suitable male candidates of the same category.

- (c) Exchange of reservation between SC & ST will not be considered.

(d) The number of vacancies to be filled up on the basis of this recruitment is subject to change by Government without notice depending upon administrative exigencies at the discretion of the State Government.

### 3. AGE :

A candidate should be under 32 (thirty two) years and over 21 (twenty one) years of age on the 1<sup>st</sup> August, 2011 i.e. he/she must not have been born earlier than 2<sup>nd</sup> August, 1979 and not later than 1<sup>st</sup> August, 1990. The upper age limit is relaxable by 5 (five) years for candidates belonging to the categories of Scheduled Castes, Scheduled Tribes, Woman, Ex-servicemen, Socially & Educationally Backward Classes (S.E.B.C.) and by 10 (ten) years for Physically Handicapped candidates.

Provided that in case a candidate who comes under more than one category mentioned above, he/she will be eligible for only one age relaxation benefit, which shall be considered most beneficial to him/her.

SAVE AS PROVIDED ABOVE, THE AGE LIMITS PRESCRIBED CAN IN NO CASE BE RELAXED.

Date of birth entered in the High School Certificate or equivalent Certificate issued by the concerned Board/Council will only be accepted by the Commission.

### 4. QUALIFICATION

A candidate must have-

- (i) Degree in Humanities(Art) or Science or Commerce with a Master's Degree in Education, or
- (ii) a Master's Degree in Humanities(Art) or Science or Commerce with a Bachelors Degree in Education, or
- (iii) obtained a B.A. (Hons.), B.Ed. or B.Sc.(Hons.), B.Ed. by successfully completion the integrated course from a Regional College of Education with a Master's Degree in Humanities(Art) or Science.

5. HOW TO APPLY : (a) (i) **Application Form** : Candidates are required to apply to the Special Secretary to the Commission in the prescribed Form which, along with other particulars are obtainable in person from the Office of the Odisha Public Service Commission at 19, Dr. P.K. Parija Road, Cuttack-753001 between 11.00 A.M. & 1.30 P.M. and 2.00 P.M. & 4.00 P.M. on any working day on cash payment of ₹30/- (Rupees thirty) only or by Registered Post on remittance of ₹70/- (Rupees seventy) only by Bank Draft/Pay Order drawn in favour of Special Secretary , Odisha Public Service Commission payable at any scheduled Bank at Cuttack with a forwarding letter addressed to the Special Secretary , Odisha Public Service Commission mentioning full name and address of the candidate, Advertisement Number and name of the post/service advertised in **BOLD CAPITAL LETTERS**.

(ii) **If the letter along with Bank Draft/Pay Order from any candidate, for supply of application form, is received in the office of the O.P.S.C. after the last date for receipt of applications, no application form will be supplied to such candidates.**

(iii) The candidates may also download the prescribed application form and copy of long advertisement from the website of the OPSC i.e. <http://opsc.nic.in>. The unreserved & S.E.B.C. candidates downloading the application form will be required to pay ₹130/- (₹30/- for prescribed application form + ₹100/- towards Examination Fee) only in shape of Bank Draft/Pay Order/Treasury Challan as provided under Paragraph-7 of the long advertisement at the time of submission of application form. The S.C. & S.T. candidates downloading the prescribed application form will be required to pay ₹30/- towards prescribed application form only in shape of Bank Draft/Pay Order/Treasury Challan as the case may be, at the time of submission of application form. The S.C. & S.T. candidates are, however, exempted from paying the examination fee.

(b) **Submission of applications :** Candidates are required to send their applications in prescribed form by Registered Post/Speed Post/Courier Service to the Special Secretary , O.P.S.C., 19, Dr. P.K. Parija Road, Cuttack-753001. **Applications received after the closing date shall not be entertained.** The Commission will not take any responsibility if the application is not received in time. The candidates may also submit their applications in closed covers in the office of Odisha Public Service Commission directly/personally on or before the last date of receipt of applications at the Counter. The closed envelope containing the application must be superscribed “Application for Odisha Education Service (School Branch)”. The candidates submitting their applications (without closed cover) directly/personally at the Counter of Odisha Public Service Commission will be given proper acknowledgement receipt.

#### **6. ACKNOWLEDGEMENT OF APPLICATIONS:**

On receipt of the application form of a candidate, the acknowledgement card (Post Card in case of downloaded application form) submitted by him/her along with the application form, will be despatched by the Commission’s Office to him/her.
