6. Age Limit 19-43, only candidates born between 02.01.1967 and 01.01.1991 (both dates included) are eligible to apply for the post; Other : Backward Communities and SC/ST candidates are eligible for usual age relaxation. (For conditions regarding the age relaxation please see Para (2) of the General Conditions)
7. Qualifications: -
  1. Pass in S.S.L.C or its equivalent qualification  
AND
  - 2 (a) National Trade Certificate in the particular trade with three-year experience in the trade after obtaining the certificate.  
OR
  - (b) National Apprenticeship Certificate in the trade with one -year experience in the trade after obtaining the certificate.  
OR

- (c) Diploma in the appropriate branch of Engineering from a Government or Government recognized polytechnic or its equivalent qualification.

Note: - (i) The experience gained by a Workshop Attender on the trade can also be deemed to be qualifying experience in the trade for selection to this post.  
(ii) Candidates belonging to SC/ST will be exempted from the qualification of experience prescribed in 2(a) and (b) above.
