1. Department : Medical Education
2. Name of post : Laboratory Technician Grade II (SR for ST only)
3. Scale of pay : Rs. 6680 – 10790
4. No. of vacancies : 1 (One)

Note:- The above vacancy is now in existence. The number of candidates to be included in the Short List/Probability List will be decided by the Commission later subject to the availability of qualified candidates. The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from ST only during the pendency of the list.

5. Method of Appointment : Direct Recruitment (Special Recruitment from among Scheduled Tribes only).

Note:- Applications received from candidates other than Scheduled Tribe will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. Age : 18-41 years. Candidates born between 02.01.1969 and 01.01.1992 (both dates included) only are eligible to apply for this post. (No other age relaxation will be allowed).

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (fifty) years.

7. Qualifications:

General: A pass in the Intermediate Examination in Science.

OR

A pass in Pre-Degree Examination in Science.

OR

A pass in Pre-University Examination ‘B’ Grade in Science.

OR

A pass in any equivalent examination.

Technical: A pass in the Medical Laboratory Technology Course (MLT) conducted in the Medical Colleges of Kerala.

OR

Any other equivalent qualification.

8. Method of submitting application:

The applications shall be submitted only through on-line facility provided in the website of Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the website of Kerala Public Service Commission viz. [www.keralapsc.org](http://www.keralapsc.org). No application fee is required. The barcode number in the application form (from the website) shall be quoted in all further enquiries/correspondences. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected. Copies of documents to prove educational qualifications, experience, age, community etc. shall be produced as and when called for by the Commission.
