Note:(i) The above vacancies are now in existence. Separate Rank List will be prepared for each district in pursuance of this notification. The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from ST during the pendency of the list.

(ii) The selection in pursuance of the notification will be made on a Revenue District basis subject to the special conditions laid down in G.O. (Ms) No 154/71/PD dated 27-05-1971. A candidate advised for appointment in one Revenue District from the Ranked List so prepared is not eligible for transfer to another district unless he/she complete five (5) years continuous service from the date of commencement of service in the former District. Even if transfer is allowed after five (5) years, it will be subject to the orders contained in G.O.(MS) No. 4/61/PD. dated 2.1.1961. Candidates already in Government service holding the post in one district are restricted from applying for the same post in another District. But they can apply for the higher posts.

(iii) Candidates from the Ranked list for district wise selection will be advised for appointment against the Headquarters Vacancies also. As per the provision in G.O (MS) No.154/71/PD dated, 27.5.71, appointment against the Headquarter vacancies will be started from Thiruvananthapuram District. Separate option need not be given for this.

(iv) Candidates are not eligible to apply for the same post in more than one district. If a candidate applies to more than one District and gets selected his/her selection will be cancelled and disciplinary action will be taken against him/her.

- 5 Method of Appointment : Direct Recruitment. (Special Recruitment from among Scheduled Tribe only).

Note: -Applications received from non-ST candidates will be rejected. Individual communications, regarding the rejection of their applications for the above reason won't be issued.

- 6 Age : 18-40. Only candidates born between 2-1-1970 and 1.1.1992 (both dates included) are eligible to apply for this post.

Note: - In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

- 2 DPT/LPT (offset) with one-year experience in offset printing in Automatic single Colour sheet fed Machines in a reputed printing establishment

OR

MGTE/KGTE printing (Higher) with three years experience in offset printing machine in a reputed printing Establishment preferably in HMT single colour offset machines.
