1. Department : NCC/Sainik Welfare (Common Notification)
2. Name of post : Lower Division Clerk(SR for ST) (From Ex-Serviceman Only)
3. Scale of pay : Rs. 5250 – 8390
4. No. of vacancies : Thiruvananthapuram - 1 (One)
Kollam - 1 (One)
Kozhikode - 1 (One)

- Note: (i) The above vacancies are now in existence. Separate Ranked List will be prepared for each District in pursuance of this notification. The list of selected candidates published by the Commission shall remain in force for a minimum period of One year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for NCC/Sainik Welfare Department during the pendency of the list.
- (ii) The Selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O(MS) No.154/71/PD dated, 27.5.1971. A candidate advised for appointment in one Revenue District from the ranked list prepared is not eligible for transfer to another district unless he/she complete Five (5) years continuous service from the date of Commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS) No. 4/61/PD dated, 02.1.1961. Candidates already in government service holding the post in one District are restricted from applying for the same post in another District. But they can apply for higher posts.
- (iii) Candidates from the Ranked list for District wise selection will be advised for appointment against the Headquarter Vacancies also starting from Thiruvananthapuram District. Separate option need not be given for this.
- (iv) Candidates are not eligible to apply for the same post in more than one District. If a candidate applies to more than one District and gets selected his/her selection will be cancelled and disciplinary action will be taken against him/her.

5. Method of Appointment : Direct Recruitment (SR from among Ex-Servicemen of Scheduled Tribes only).

Note:- In the absence of qualified Ex-Servicemen candidates, applications from Non-Ex-Servicemen ST candidates will also be considered for appointment (G.O(MS) No. 207/86/H.Edn. dated 02.08.1986). Applications received from non ST candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason won't be issued.

6. Age : 18-50. Only Candidates born between 02.01.1960 and 01.01.1992 (both dates included) are eligible to apply for this post.

Note:- In the case of Non Ex-Servicemen ST candidates the upper age limit should not exceed 40 years. In the absence of qualified Non Ex-Servicemen ST candidates within the upper age limit of 40 years, the upper age limit shall be relaxed upto 50 years. No other age relaxation will be allowed.

7. Qualifications : A pass in SSLC or its equivalent Examination.

Note:- No copies of documents should be attached with the application. Self attested copies of the certificates required as per para (15) of the general conditions (including those of the mark list of the SSLC

examination (with endorsement) the discharge certificate and the pension payment order) should be produced along with the originals as and when called for by the Commission.

8. Method of submitting application

The applications shall be submitted On-line only. Detailed instructions regarding the submission of applications are available in the website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The barcode number in the application form (from the website) shall be quoted in all further enquiries/correspondence. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected.

9. Last date for receipt of applications : **02.02.2011 Wednesday upto 5 p.m.**

11. Paragraphs two, three and twenty seven [except the conditions laid down in the Rule 3(c) of Part II of the Kerala State and Subordinate Service Rules] are not applicable to this selection.

12. Appointments are made subject to the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O (P) No. 21/76/PD dated 17.01.1976 and G.O (P) No. 25/94/GAD dated 22.01.1994, allowing Special Reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3 (c), 17(a), 17(b) of Part II of Kerala State Subordinate Service Rules, 1958.
