This is the third NCA Notification for the above mentioned communities and the same is issued due to paucity of qualified candidates after I and II NCA Notifications.

3. Scale of pay : Rs.10000 – 15200/-

4. Qualifications:-

1. Post Graduate Degree in the respective discipline from a recognized University (Viz.MD/MS/DNB)

2. Permanent Registration under State/Central Medical Registration Act

(1) Provisional Registration with any Medical council will not be accepted.

(2) Candidates who have secured Permanent Registration with other State/Central Medical Council will have to get them registered under the Travancore Cochin Medical Practitioners Act before they join duty in the post.

(3) Those who are appointed in the post should serve for four (4) years during the first ten year of their service (including the period of training) anywhere in India or any other Foreign country under defence service or assignments connected with defence. Those who have completed 45 years of age are exempted from the above Compulsory Military Service.

5. Method of appointment : Direct Recruitment (from candidates belonging to the communities mentioned in Para 2 above. Application submitted by candidates other than the communities mentioned above will be rejected. No rejection memo will be issued to them individually)

Note:- 1. Applications received from Scheduled Caste candidates for the vacancies marked for Scheduled Tribe community and vice versa will be considered in the absence of candidates from the concerned community.

2. Separate applications shall be submitted by online in each category in case, applicants desire to apply for more than one post.

6. Age limit: 24-43 "Only candidates born between 02.01.1967 and 01.01.1986.(both dates included) are eligible to apply for the post .In the case of Scheduled Caste/Scheduled Tribe candidates and candidates belonging to Other Christians. (ie, adult members of Scheduled Caste converted to Christian religion and their children) the upper age limit will be up to 45 (Forty five) years .

(For conditions regarding the age relaxations please see Para 2 of the General Conditions, except Para 2 (i))

7. Mode of Sending Applications: - The applications should be submitted only through online facility . Detailed Instructions regarding the submission of applications are available in the Website of the Kerala Public Service Commission, viz www.keralapsc.org. No application fee is required. The barcode number in the application form shall be quoted in all further enquires/correspondence. In case a competitive test is conducted for this post, the details would be published in the PSC Bulletin and website of the Commission. The Admission Ticket for the test may be downloaded from the website by using the Bar code Number. Applicant employed under Kerala Government Service shall obtain a receipt from the Head of Office as mentioned in Para 20 of General Conditions under Part II of the Gazette by hand overing the down loaded copy of the application sent to the Commission. The original receipt and documents to prove qualification, age and community have to be produced as and when called for. E mail address of applicants may also be

shown in the application. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.
