Applications are invited online only from qualified candidates belonging to the reservation group viz. Other Backward Communities (OBC) of Kerala State for appointment in the under mentioned post in Kerala Government Service.

1. Department : Medical Education
2. Name of Post : Rehabilitation Technician Gr.II (Orthotics)
3. Scale of Pay : Rs. 4990-7990/-
4. No.of vacancies : OBC – 1 (One)

The above vacancy is now in existence. The Ranked list published by the Commission in pursuance of this notification will be valid till candidates are advised and appointed against the above vacancy earmarked for Other Backward Communities (OBC) but kept unfilled due to the paucity of candidates during the currency of the Ranked List published on 20.10.2009 for the post. 5. Method of appointment : Direct Recruitment (from OBC candidates only)

Note: Applications submitted by candidates other than those belonging to Other Backward Communities will be rejected. No rejection memo will be issued to them individually.

6. Age : 18-38; Only candidates born between 02.01.1972 and 01.01.1992 (both dates included) can apply for the post [including relaxation in para 2 (i) of the General Conditions]

[For conditions regarding other age relaxation please see part II of the General Conditions except para 2 (i)]

Note:- Persons who have undergone successful Training in the Artificial Limb Centre attached to the Medical College, Thiruvananthapuram under 'Half a Million Job Programme' will be eligible for relaxation of five years in the upper age limit.

7. Qualifications:

1. Pass in Standard VII(New) or its equivalent.
2. a) Successful completion of the Rehabilitation Technician Training Course in Orthotics conducted in the Medical College, Thiruvananthapuram or other recognized institutions.

In the absence of persons with the above qualifications, candidates with the following qualification will be considered.

- b) Successful completion of Certificates Course or Certificates in Orthotics obtained from ITI or other recognized Trade Schools.

The applications shall be submitted by online only provided in the Website of Kerala Public Service Commission.
