Applications are invited online only from qualified candidates belonging to the reservation group of communities of Kerala viz.LC,OX and Dheevera for selection to the under mentioned post in Kerala Government Service.

1. **Department** : Medical Education
2. **Name of Post** : Dental Hygienist Gr.II
3. **Scale of Pay** : Rs. 4000-6090 (PR)
4. **Number of Vacancies** : Latin Catholic – 1 (One)  
OX – 1(One)  
Dheevera -1 (One)

The above vacancies are now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for LC, OX, and Dheevera communities as unfilled due to paucity of candidates during the currency of the Ranked List, published on 30.12.2008 (Category Number 114/2007). This second NCA notification for the above communities is issued due to paucity of candidates in the Ranked List published on 7.8.2010 (Gazette date: 30.12.2009 and Category No.481/09).

5. **Method of appointment** : Direct Recruitment (from among L.C, OX and Dheevera communities only).

Note: Applications submitted by candidates belonging to other than LC,OX and Dheevera Communities will be rejected. No rejection memo will be issued to them individually.

6. **Age** : 18-38;only candidates born between 2.1.1972 and 1.1.1992 (both dates included) are eligible to apply for this post. (Including the age relaxation in Para 2(i) of the General conditions).

Note: The adult converts of Scheduled Castes to Christianity (O.X) including their Children are eligible to get age relaxation upto 5 years in the upper age limit.

(For conditions regarding the other age relaxation please see Para 2 of the General Conditions, except Para 2(i))

  1. Minimum General Educational qualification of Pre Degree or +2
  2. Pass in Dental Hygienists Course conducted in Dental College.
