Applications are invited on-line only from qualified candidates belonging to reservation group of communities of Kerala State viz, Dheevera for the under mentioned post.

4. Number of vacancies : Kasargod : Dheevera-1(one)

Note:- 1.Conventional type applications will be summarily rejected. Candidates shall apply only through online application available with the Kerala public service commission website www.keralapsc.org.

2.Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued.

3.Separate Ranked List will be prepared for Kasargod district in pursuance of this notification. Ranked Lists thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

4. The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms) No 154/71/PD dated, 27-05-1971.A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district. Even if transfer is allowed after five years, it will be subject to the rules in G.O.(MS) No. 4/61/PD. dated, 2.1.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

- 5 Method of Appointment : Direct Recruitment.(from candidates belonging to Dheevera communities only)
- 6 Age Limit : 18-42 Only candidates born between 2.01.1968 and 01.01.1992.(both dates included) are eligible to apply for this post. (Including the relaxation as per para 2(1) of General Condition).

Note:- For conditions regarding other age relaxation please see para 2 of the general conditions.

7. Qualifications

A Degree in Arabic or Arabic as one of the optional subjects under pattern II of part III and B.Ed/B.T/L.T conferred or recognized by the Universities in Kerala

OR

A title of Oriental Learning in Arabic awarded or recognized by the Universities in Kerala (if such title has been declared as equivalent to part III of degree) and certificate in Language Teacher Training issued by the commissioner for Government examinations, Kerala

Note : (i) Post Graduates in Arabic are also eligible to apply if they possess B.Ed/B.T/L.T

(ii) B.Ed shall be in the concerned language

(iii) Disciplines in which BA/MA and B.Ed. degree were obtained should be mentioned.

(iv) Those candidates who secured BA/MA/B.Ed/B.T Degree from the Universities outside Kerala should note in the application form the number and date of relevant orders recognizing the said degree.

8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT.

(1) Preference will be given as laid down in G.O. (MS) No.50/70/PD dated 12.2.70 and G.O.(MS) No.9/78/G.Edn. Dated 21.1.78 to the wives of jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base establishment are included under the terms of jawans, Wives of jawans should note in the application that they are wives of jawans. Such candidates should obtain proper certificates from the Officer commanding stating the name, Military rank and Military address of their husbands and produce the same as and when required by the Commission (G.O)(MS) No.509/64/Edn. Dated 19.9.1964, G.O.(MS) No.614/65/Edn, Dated 09.11.65 and G.O.(MS) No.243/66/Edn,Dated 27.5.66.

(2) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O. (MS) No.122/75/G.Edn. dated 27.05.1975 and GO(MS) No.50/70/PD dated 12/02/1970)

(3) Teacher of the government primary and Nursery School who are graduates and are otherwise qualified will be exempted from upper age limit [G.O.(MS) No.185/70/Edn dated 18/04/1970 and G.O.(MS) NO.466/70/Edn dated 11/11/1970]. They should produce proper certificate from authorities concerned as and when required by the commission.

Note:- The candidates who claim concession by virtue of any of the above reason should state “Are you eligible for age relaxation as “yes” on the online application and give details in the space following. Otherwise the application are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age. (See para 2 of General conditions)

9. Mode of sending applications:

Candidates shall apply online only to the website of the Kerala Public service commission viz. www.keralaosc.org. No application fee is required. The candidates applying through on-line should keep the print out (Receipt) of their applications and the barcode number shall be quoted in all further enquiries/correspondence. Documents to prove qualifications, age and community etc have to be produced as and when called for. Applications, which are submitted not in accordance with the instructions given the website will be summarily rejected.
