Applications are invited online only exclusively from qualified candidates belonging to reservation group of communities of Kerala State viz. Scheduled Caste, Latin Catholic and Muslim for the under mentioned post.

- 1 Department : Education
- 2 Name of post : U.P School Assistant (Malayalam Medium)
- 3 Scale of pay : Rs. 6680 – 10790
- 4 Number of vacancies : District wise
Idukki – Scheduled Caste - 1(One)
Alappuzha – Latin Catholic – 1(One)
Pathanamthitta – Muslim – 1(One)

NOTE:- (i) Conventional type applications will be summarily rejected. Candidates shall apply only online application to the Kerala Public Service Commission website www.keralaps.org.

- (ii)** Applications submitted by Candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued.
- (iii)** Separate Ranked List will be prepared for each district in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

- (iv)** Reservation community candidates shall submit application for the post to the concerned district officer where the vacancy is existing for their respective communities and note the name of that district against the relevant column of the application. Applications should not be submitted to more than one district in pursuance of this notification. If applications are submitted contrary to the above direction and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (v)** The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G O (Ms) No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No. 4/61/PD, dated 2.1.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5 **Method of appointment** : Direct Recruitment (From candidates belonging to SC, LC and Muslim communities only). [In the absence of candidates belonging to Scheduled Caste communities, candidates belonging to scheduled tribe will be considered].

6 **Age limit** : 1. 18-42. Only candidates born between 02.01.1968 and 01.01.1992 (both dates included) are eligible to apply for this post in the case of Muslim, LC.

7 2. 18-44. Only candidates born between 02.01.1966 and 01.01.1992 (both dates included) are eligible to apply for this post in the case of SC/ ST.

Note:- For conditions regarding other age relaxation please see para 2 of the General Conditions.

7. **Qualifications :-**

1.A pass in SSLC Examination conducted by the Commissioner for Government Examinations, Kerala or its equivalent.

OR

A pass in Pre-Degree Examination conducted by any of the Universities in Kerala or any Examination recognized by any such Universities as equivalent to Pre-Degree Examination.

OR

A pass in a Higher Secondary Examination conducted by the Board of Higher Secondary Examination, Kerala or any other Examination recognized by Government as equivalent thereto.

AND

2.A pass in TTC Examination conducted by the Commissioner for Government Examinations, Kerala.

OR

A degree in any subject and B.Ed/BT/LT conferred or recognized by the Universities in Kerala.

Special Note:- 1.Candidates who have not studied the Regional Language 'Malayalam' either under Part I or Part II or as medium of instruction of SSLC will not be eligible for appointment to the post.

2.Question paper for the written test if any will be in Malayalam. The candidates should answer the questions in Malayalam.

8 **SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT**

(1) Preference will be given as laid down in G.O.(MS) No.50/70/PD dated 12.2.70 and G.O.(Ms) No. 9/78/G.Edn. dated 21.1.78 to the wives of Jawans in the matter of recruitment as teachers if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the terms, Jawans. 'Wives of Jawans' should select "Are you entitled to any priority" as 'Yes' on online application and give the details in the space that follows. Such candidates should obtain proper certificates from the officer commanding stating the name, military rank and military address of their husband and produce the same as and when required by the Commission (G.O.(MS) No.509/64/Edn. Dated 19.9.64, G.O.(MS) No. 614/65/Fin dated 09.11.65 and G.O.(MS) No.243/66/Edn. Dated 27.5.66).

(2) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers. [G.O (MS) No. 122/75/G.Edn. dated 27.05.75 and G.O (MS) No. 50/70/PD dated 12.02.1970]

Note:- The candidates who claim concession by virtue of any of the above reasons should select "Are you eligible for age relaxation" as 'yes' on the online application and give details in the space following. Otherwise the applications are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age. (See para 2 of General Conditions).

9. **Mode of Submitting Applications:**

The applications are available in the website of the Kerala Public Service Commission viz www.keralapsc.org. No application fee is required. The Candidates applying on-line shall keep the print out (Receipt) of their applications and the barcode number shall be quoted in all further enquiries/correspondence. Documents to prove qualification, age and community have to be produced as and

when called for. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected.
