Applications are invited online only exclusively from qualified candidates belonging to reservation group of communities of Kerala State viz. Viswakarma for appointment in the under mentioned post.

NOTE: (i) Conventional type application for the above post will be summarily rejected. Candidates can apply through online application available at the Kerala Public Service Commission website.

(ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued.

(iii) Separate Ranked List will be prepared for Kannur district in pursuance of this notification. Ranked List thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against all the NCA turns identified as unfilled during the currency of the Ranked List published for the post in Kannur district.

(iv) Reservation community candidates should submit application for the post to Kannur district where the vacancy is existing and note the name of that district against the relevant column of the application.

(v) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O(MS)No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O (MS)No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post.

5. Method of appointment : Direct Recruitment (From the respective community).

6. Age limit : 18-42 Only candidates born between 02.01.1968 and 01.01.92 (both dates included) are eligible to apply for this post. (Including the relaxation as per para 2 (1) of General Conditions).

Note: For age relaxation, please see para 2 of the general conditions under Part II of this notification subject to the condition that the maximum age limit shall not exceed 50 (fifty) years

7. Qualifications:

A Degree in Sanskrit and B.Ed/B.T/L.T conferred or recognized by the Universities in Kerala.
OR

A Title of Oriental Learning in Sanskrit awarded or recognized by the Universities in Kerala and Certificate in Language Teachers Training issued by the Commissioner for Government Examination,

Kerala. In regard to High School Assistant (Languages) in Government Schools, a title of Oriental Learning in the concerned Languages awarded or recognized by the Universities in Kerala shall also be accepted in lieu of Degree if these titles have been declared as equivalent to Part III of the Degree.

Note: 1. Siksha Sastri Examination of the Rashtriya Sanskrit Sansthan and 'Siksha Sastri' Examination of the Kameswar Singh Darbhanga University of Bihar will be treated as equivalent to B.Ed Degree Examination of the Universities in Kerala for the purpose of appointment as High School Assistants(Sanskrit).

2. Post Graduates in Sanskrit are also eligible to apply provided they have B.Ed/B.T/L.T
3. B.Ed should be in the concerned language.

8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT :

- (1) Preference will be given as laid down in G O(MS)No.50/70/PD dated 12.2.70 and G.O(MS)No.9/78/G.Edn.dated 21.1.78 to the wives of jawans in the matter of recruitment as teachers if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the terms Jawans. Wives of Jawans must select "Are you entitled to any priority" as 'yes' on online application and give the details in the following space. Such candidates should obtain proper certificates from the officer commanding stating the name, military rank and military address of their husband and produce the same as and when required by the Commission (G O (MS) No.509/64/Edn.dated 19.9.64, G O (MS)No.614/65/Fin dated 09.11.65 and G O(MS) No.243/66/Edn.dated 27.5.66.
- (2) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers G.O(MS)No.122/75/G.Edn dated 27.05.75.
- (3) Teachers of the Government Primary and Nursery schools who are Graduates and are otherwise qualified will be exempted from upper age limit.G.O(MS)No.185/70/Edn.dated 18.04.70 and G O (MS) No.466/70/Edn.Dated 11.11.1970. They should produce proper certificates from authorities concerned, as and when required by the Commission.

Note: The candidates who claim concession by virtue of any of the above reasons should select "Are you eligible for age relaxation" as 'yes' on the online application and give details in the space.

9. Last date of receipt of applications : **02/02/2011 Wednesday upto 5 p.m**

10. Application form and application fee:

Application shall be submitted on-line only . Detailed instructions regarding the submission of applications are available in the Website of the Kerala Public Service Commission viz., www.keralapsc.org No application fee is required. The barcode number in the application form shall be quoted in all further enquiries/ correspondences. Documents to prove qualification, age and community have to be produced as and when called for. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.

Note: Candidates should take a print out (receipt) of their admitted application and retain the same after entering the barcode number for further communications.
